Dear Madam or Sir,

Criticism about of the social dimension of the EU's enlargement policy is common in Western Balkan societies. Enlargement policy over the past years has prioritized the creation of functioning market economies' and supply-side skill acquisition strategies. Social issues, in contrast, have not been on the top of the agenda. Recent FES research found that social exclusion remains widespread – citizens' political, economic and social participation is inadequate.

Last year, the European Commission published a new enlargement strategy for the Western Balkans announcing "a new reinforced social dimension". Its delivery was foreseen in the realms of employment, education, and healthcare. Placing increased emphasis on social matters is good news in a region affected by significant economic and social inequalities. But will this pledge materialize?

On behalf of the *Friedrich-Ebert-Stiftung and IRIS network*, we kindly invite you to participate in an expert roundtable on enlargement, social inclusion policies and migration related challenges in the Western Balkans.

Current research findings will form the basis of a two-hour exchange on some key if neglected aspects of European integration in the Western Balkans. The event will bring together representatives of the Commission, MEPs, experts, trade unions, and civil society to discuss how a reinforced social dimension in enlargement policy can be brought to life.
